Bids received after this deadline will be rejected.

Bids shall be opened in the presence of bidder's representatives who choose to attend **14:00** hour on **14, January 2020 (2076-09-29)** at the office of **Gorkhapatra Corporation, Dharmapath, Kathmandu**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security as mentioned above which shall be valid for Minimum **30 days** beyond the bid validity period.
